Cayce Public Safety Foundation Board of Directors Meeting Minutes May 22, 2023

- Call to Order/Welcome: Pamme Eades called the meeting to order at 5:45 PM.

• Approval of Minutes:

The meeting minutes were reviewed. FD Chief Bullard made a motion to approve them and PD Chief Cowan seconded the motion. The motion was unanimously approved.

Treasures Report

Kay Hutchinson gave a report of the organization's current financial status (see handouts).

Old Business

Steel Paws

Kay Hutchinson went over the income and expenses of the event. She indicated the current figures were not yet finalized (see handouts of account activity).

The board briefly discussed the Steel Paws event and what could be done in the future to make it more successful.

Midlands Gives

Pamme reported there were 32 donations totaling \$3,371.25. Pamme requested these funds to be set aside or reserved for the needs of the FD. Kren Sanders made a motion to grant this request and April Blake seconded the motion. The measure was unanimously approved by the board.

Cayce Farmers Market

Borrd members recently manned a booth to sell foundation merchandise at the Cayce Farmers Market (along with other local artists and vendors). Thes effort brought in approximately \$386.00 in sales during the 5-hour event.

New Business

Addition to the organization Bi-Laws:

Addition of section 7.10: Dissolution

"Upon the dissolution of this foundation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the IRS code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose."

April Blake made a motion to approve this addition to the bi-laws. PD Chief Cowan seconded the motion and the board unanimously approved the measure.

Selling merchandise on the organization website

Additional Fundraising needed

Russ Shumard gave an update on the advent calendar fundraising idea. He has reached out to a local person who may be interested in doing the needed graphic design at little or no cost. He has also reached out to the company that makes and manufactures the chocolate calendars (Arif Somji of Chocovana Chocolatier NA). He e-mailed the instructions, steps needed to submit, template of the size for the graphic designer, etc. Russ will e-mail this information to the board members to get additional ideas on what decisions the organization needs to take to pursue this campaign.

Miles Fisher gave a briefing and update on the golf tournament.

PD Chief Cowan requested \$2,200.00 to purchase a pallet of dog food for the K-9 unit (50 bags, 40 lbs each bag). Karen Sanders made the motion to approve the funding and Trinessa Dubas seconded the motion. The measure was unanimously approved by the board.

PD Chief Cowan also requested \$2,255.00 in funding for uniform needs for the members of the K-9 officers. Karen Sandes made a motion to grant the funding and Trinessa Dubas seconded the motion. The board unanimously approved the measure.

Request to change standing rules to allow President Pamme Eades to approve expenditures/requests for funding/projects up to \$500.00 without a vote from the board.
