Regular Council Meeting  
March 6, 2018**

The March Regular Council Meeting was held this evening at 6:00 p.m. in Council Chambers. Those present included Mayor Elise Partin, Council Members Tara Almond, Phil Carter, Eva Corley and James Jenkins. City Manager Rebecca Vance, Assistant to the City Manager Rachelle Moody, Municipal Clerk Mendy Corder, Municipal Treasurer Garry Huddle, Planning and Development Director Carroll Williamson, City Attorney Danny Crowe, and Director of Public Safety Byron Snellgrove were also in attendance.

Mayor Partin asked if members of the press and the public were duly notified of the Council Meeting in accordance with the FOIA. Ms. Corder confirmed they were notified.

**Call to Order**

Mayor Partin called the meeting to order. Council Member Corley gave the invocation. Mayor Partin stated that the City likes to honor those who have served their country in the military by asking local veterans to lead the assembly in the Pledge of Allegiance. She invited Mr. Mike Causey to join Council on the dais. She stated that Mr. Causey served in the Air Force as a medic for a total of 33 years both in active duty and in the reserves. He retired as an E8, a senior master sergeant. Mr. Causey led the assembly in the Pledge of Allegiance. Mayor and Council thanked him for his service.

**Approval of Minutes**

Council Member Almond made a motion to approve the February 7, 2018 Regular Council Meeting minutes and the February 20, February 21, February 23 and February 27 and March 1, 2018 Special Council Meeting minutes a written. Council Member Corley seconded the motion which was unanimously approved by roll call vote.

**Public Comment Regarding Items on the Agenda**

No one signed up for Public Comment.

**Presentations**

- A. Presentation of the West Metro Bike and Pedestrian Master Plan and Bike Share Study

Mr. Jared Draper with Toole Design Group presented the West Metro Bike and Pedestrian Master Plan and West Metro Bike Share Feasibility Study to Council. He reviewed the goals of the plan, the planning process and the implementation of the project. He stated that the early action projects for Cayce were enhanced crosswalks at 12<sup>th</sup> Street @ Frink Street, wayfinding signage on Naples Avenue guiding people to the Riverwalk, traffic calming on Julius Felder Street, wayfinding signage on Fort Congaree Trail to the Cayce Riverwalk, safety improvements on State Street @ Poplar Street and enhanced crosswalks on Knox Abbott Drive @ 12<sup>th</sup> Street. Council thanked Mr. Draper for taking the time to present the plan and study to them.

### **Proclamations and Resolutions**

#### **A. Approval of Proclamation – March for Meals**

Council Member Almond made a motion to approve a Proclamation proclaiming March the annual March for Meals Month. Council Member Jenkins seconded the motion which was unanimously approved by roll call vote.

#### **B. Consideration and Approval of Resolution Approving Law Enforcement Assistance and Support Agreement with the Richland – Lexington Airport District**

Council Member Jenkins made a motion to approve a Resolution approving the Law Enforcement Assistance and Support Agreement with the Richland – Lexington Airport District. Council Member Corley seconded the motion which was unanimously approved by roll call vote.

#### **C. Consideration and Approval of Resolution Approving Law Enforcement Assistance and Support Agreement with Springdale Police Department**

Council Member Almond made a motion to approve a Resolution Approving a Law Enforcement Assistance and Support Agreement with Springdale Police Department. Council Member Jenkins seconded the motion which was unanimously approved by roll call vote.

### **Ordinances and Other**

#### **A. Discussion and Approval of Ordinance 2018-02 Amending Sec. 2-144.9 (Procurements and Contracts) of Chapter 2 (Administration) – First Reading**

Ms. Moody stated that the City's Code of Ordinances and Purchasing Policy has been updated to allow Council to waive the informal and formal bid procedures when it

is to the advantage of the City to acquire goods and/or services on the basis of a previously awarded bid or contract. It also allows Council to waive the bid procedures for professional services when the person employed is customarily employed on a fee basis rather than by competitive bidding. For example, an appraiser, architect-engineer, auditor, attorney or physician. She stated that these updates have been made to facilitate continuity of an incomplete project through contract extension as well as to increase efficiency through time and cost savings by not re-bidding a project for extensions.

After discussion, Council Member Almond made a motion to approve Ordinance 2018-02 on First Reading. Council Member Corley seconded the motion. Council Member Carter and Council Member Jenkins voted no. Mayor Partin voted yes, the motion passed.

**B. Discussion and Approval of Ordinance 2018-03 Amending Appendix A (Classification and Rates) of the City Business License Ordinance – First Reading**

Mr. Williamson stated that Council approval was needed for an Ordinance amending the City of Cayce Business License Ordinance to make further changes to Appendix A (“Classification and Rates”) to conform to the language of the Municipal Association of South Carolina (MASC) Model Business License Ordinance. He stated that On December 4, 2012, City Council amended Appendix A of the business license sections of the City Code to address changes in State law relating to the broker’s premium tax. An agreement was established for MASC to serve as the City’s agent for purposes of the administration of the municipal broker’s premium tax.

Mr. Williamson stated that the MASC has requested that additional language in the City’s business license concerning insurance companies be amended to fully conform to the MASC model business license. This amendment has no effect on the current agreement with MASC or the current agreement with the Farm Bureau.

Council Member Corley made a motion to approve Ordinance 2018-03 on First Reading. Council Member Almond seconded the motion which was unanimously approved by roll call vote.

**City Manager’s Report**

Ms. Vance thanked Council for giving her the opportunity to work at Cayce and said she enjoyed her time with the City. She stated that two of the recommendations in the Bike Ped Plan are items that are in the Knox Abbott Pedestrian Safety and Traffic Calming Project. She stated that the top of the new water tank was being hoisted onto

the tank the following day. She stated that Mr. John Banks was being recognized for all his work with Tartan Day South with a Senate Resolution. He also has been invited to Washington DC for the 20th anniversary celebration of the National Tartan Day holiday in April. She stated that Ms. Moody and Mr. Williamson attended the International Council on Shopping Centers in Charlotte. She stated that the event was a great way to network with retail businesses that might be interested in locating to Cayce. Ms. Vance stated that the Employee Awards Safety Lunch was the next day. The lunch is a thank you to staff for recently being given a safety award.

He told everyone at the lunch that Ms. Vance's financial decisions for the City during her tenure were second to none. He stated that the City was losing a fine City Manager and it was the City's loss. Of course

Council understand her reasons for needing to get back home to her parents and support her but hate to see her go. Council Member Carter stated that Ms. Vance did a great job while with the City and made herself a part of the community. He stated she would be missed by Council, staff and the residents. He stated that the City was in good shape financially and morale was high and Ms. Vance had a lot to do with both.

Special Council Meeting  
March 21, 2018**

A Special Council Meeting was held this afternoon at 5:00 p.m. in Council Chambers. Those present included Mayor Elise Partin, Council Members Tara Almond, Phil Carter, Eva Corley and James Jenkins. Assistant to the City Manager Rachelle Moody, Municipal Clerk Mendy Corder, City Treasurer Garry Huddle, Planning and Development Director Carroll Williamson, Director of Public Safety Byron Snellgrove and City Attorney Danny Crowe were also in attendance.

Mayor Partin asked if members of the press and the public were duly notified of the meeting in accordance with the FOIA. Ms. Corder confirmed they were notified.

**Call to Order**

Mayor Partin called the meeting to order and Council Member Jenkins gave the invocation. Mayor Partin announced that Girl Scout Troop 339 were in attendance and invited them to lead the assembly in reciting the Pledge of Allegiance. The Girl Scouts were attending the meeting as part of their civics badge. After the meeting Mayor Partin and Council Member's Almond and Corley met with the Girl Scouts so they could ask Mayor and Council questions about their experiences in politics.

**Public Comment Regarding Items on the Agenda**

Ms. Corder stated no one had signed up for public comment.

**Resolutions and Ordinances**

- A. Consideration and Approval of Resolution Approving Financing Terms for Utility Fund Meter Lease Purchases

Ms. Moody stated that the lease purchase agreement was for the new water meters that the City was purchasing as part of the Waterline Replacement Project. She stated that the water meters are Division 7 of the project and 3,620 meters are being purchased. She stated that the total cost included the cost of the meters and installation. Every home in the project area is receiving a new meter. The meters cost \$1.2 million dollars and will be paid for over four years. Ms. Moody stated that payments have already been budgeted for the FY18 budget.

Council Member Jenkins made a motion to approve the financing terms of the utility fund meter lease purchases. Council Member Almond seconded the motion which was unanimously approved by roll call vote.

### **City Manager's Report**

Ms. Moody stated that staff were working together well since Ms. Vance's departure. She stated that Friday, March 30 was Good Friday and the City would be closed. She stated that Friday's sanitation would be picked up Wednesday, March 28. She stated that staff just purchased a new 6 seater golf cart. The golf cart can be used at City events to transport people. She stated it would also be used to take any mobility impaired or senior residents through the City's Riverwalk so they can experience it.

### **Council Comments**

Mayor Partin welcomed Ms. Moody and thanked her for stepping up. Council Member Jenkins thanked Ms. Moody and wished her well. Council Member Carter stated that he had been contacted by a constituent regarding Martin Marietta possibly buying homes in Riverland Park and moving the houses out of the neighborhood. He asked if anyone knew anything about the homes being bought by a third party. Mayor Partin asked Council Member Carter if he had contacted someone with Martin Marietta. He said he had not but he had talked to a real estate agent. Mayor Partin stated that Riverland Park's neighborhood meeting was in the near future and this topic was on the agenda if he wanted to attend the meeting.

## **ISSUE**

Council approval is needed for the First Reading of an Ordinance amending Section 6.9-1("Flood Damage Prevention Ordinance").

## **BACKGROUND/DISCUSSION**

On January 5, 2018, the Federal Emergency Management Association (FEMA) sent a letter stating that the preliminary Flood Insurance Study (FIS) and a Flood Insurance Rate Map (FIRM) for Lexington County had been finalized. The FIS and FIRM will go into effect on July 5, 2018. In November 2017, City Council approved a text amendment that adopted the new flood maps for the portion of Cayce in Richland County and amended some of the language in our flood ordinance in order to be compliant with the National Flood Insurance Program (NFIP). With this text amendment, the only change to the Ordinance is to the date of the Lexington County maps to July 5, 2018, which is a requirement of the NFIP.

The Planning Commission met on March 19, 2018, to hear Public Comment about the suggested changes. No members of the public were present at the meeting. The Planning Commission voted unanimously to recommend the amendment.

## **RECOMMENDATION**

The Planning Commission recommends Council approve First Reading of an Ordinance amending Section 6.9-1("Flood Damage Prevention Ordinance") of the Zoning Ordinance of the City of Cayce.

**ORDINANCE 2018-04**  
**Amending the City's Flood Damage**  
**Prevention Ordinance (Section 6.9-1**  
**of the City Zoning Ordinance)**

**WHEREAS**, Council has determined that it is in the interest of the City and the public, and the health, peace, safety and order of the City, to amend its current Flood Damage Prevention Ordinance, which is a part of the City Zoning Ordinance, so as to revise a certain provision (Article I, Section D) to include the date of new flood maps,

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the City of Cayce, in Council, duly assembled, as follows:

Section D ("Lands to Which this Ordinance Applies") of Article I ("General Standards") of the City's Flood Damage Prevention Ordinance, also designated as Section 6.9-1 of the City Zoning Ordinance, is hereby amended to include the date of new flood maps by substituting the words "July 5, 2018" for the words "February 20, 2002."

This Ordinance shall be effective from the date of second and final reading.

flood conditions by requiring that uses vulnerable to floods, including facilities which serve such uses, be protected against flood damage at the time of initial construction. Uses of the floodplain which are dangerous to health, safety, and property due to water or erosion hazards, or which increase flood heights, velocities, or erosion are restricted or prohibited. These provisions attempt to control the alteration of natural floodplains, stream channels, and natural protective barriers which are involved in the accommodation of flood waters, and control filling, grading, dredging and other development which may increase flood damage or erosion. Additionally, the ordinance prevents or regulates the construction of flood barriers which will unnaturally divert floodwaters or which may increase flood hazards to other lands.

The objectives of this ordinance are to protect human life and health, to help maintain a stable tax base by providing for the sound use and development of flood-prone areas in such a manner as to minimize flood blight areas, and to insure that potential home buyers are notified that property is in a flood area. The provisions of the ordinance are intended to minimize damage to public facilities and utilities such as water and gas mains, electric, telephone, and sewer lines, streets and bridges located in the floodplain, and prolonged business interruptions. Also, an important floodplain management objective of this ordinance is to minimize expenditure of public money for costly flood control projects and rescue and relief efforts associated with flooding.

Floodplains are an important asset to the community. They perform vital natural functions such as temporary storage of floodwaters, moderation of peak flood flows, maintenance of water quality, groundwater recharge, prevention of erosion, habitat for diverse natural wildlife populations, recreational opportunities, and aesthetic quality. These functions are best served if floodplains are kept in their natural state. Wherever possible, the natural characteristics of floodplains and their associated wetlands and water bodies should be preserved and enhanced. Decisions to alter floodplains, especially floodways and stream channels, should be the result of careful planning processes that evaluate resource conditions and human needs.

D. Lands to Which this Ordinance Applies. This ordinance shall apply to all areas of special flood hazard within the jurisdiction of the City of Cayce as identified by the Federal Emergency Management Agency in its Flood Insurance Study, dated July 5, 2018, and December 21, 2017, with accompanying maps and other supporting data that are hereby adopted by reference and declared to be a part of this ordinance. Upon annexation any special flood hazard areas identified by the Federal Emergency Management Agency in its Flood Insurance Study for the unincorporated areas of Lexington & Richland Counties, with accompanying map and other data are adopted by reference and



In attendance: Dr. Pete Cassidy, John Hert, Mark Burt, Lynda Murray, Suki Patel and Aaron Kot  
City Representatives: Mendy Corder, Katinia Taylor

Dr. Pete Cassidy called the meeting to order. The Committee reviewed the Accommodations Tax Report for FY17-18 and Accommodations Tax Funding request for FY18-19. The Committee then reviewed each application requesting Accommodation Tax funds. Before discussing their recommendations, Mr. Patel suggested that the applicants have better marketing techniques to advertise the Cayce restaurants and hotels.

Mr. Burt made a motion to recommend that Airport High School's Boys and Girls Soccer Tournaments receive the amount requested. Ms. Murray seconded and the vote was unanimous. Dr. Cassidy stated that the Airport High School Tennis Fundraiser requested \$3,410 but he did not think the fundraiser would bring many visitors to the restaurants or hotels in the City of Cayce. Mr. Hert agreed and stated that only \$500 was allocated in the application for advertising. He explained that Accommodations Tax funds can only be used to market an event. Mr. Burt made the motion to recommend Airport High Education Fundraiser receive \$500, Mr. Patel seconded the motion and the vote was unanimous.

Mr. Burt made a motion to recommend the amount requested for both the Museum Traditions and the Museum Aide position. Mr. Hert seconded the motion.

The Cayce Events Committee requested \$10,000 from Accommodations Tax Funds to have a music festival in the fall of 2018. The Committee did not feel that the Events Committee had enough time to prepare and have a successful new event by the fall of 2018. The Accommodations Tax Committee as a whole did not feel comfortable making any decisions on the funding requested and asked that the discussion get shifted to Mayor and Council. Mr. Hert made the motion to ask Council to make the decision on whether to give funding to the Cayce Music Festival. Mr. Patel seconded the motion which was unanimously approved.

Mr. Patel made a motion to recommend that the Guided Nature Tour receive the funds requested. Mr. Kot seconded the motion which was unanimously approved.

The River Alliance requested \$2,000 more in funds for FY18-19 for Tartan Day South. The Committee stated that the event is very successful, brings a lot of visitor to the City of Cayce and is getting better each year. Mr. Kot made a motion to approve the requested funds. Mr. Patel seconded the motion which was unanimously approved.

Mr. Hert advised that he was resigning from the Committee due to health issues and that the Tuesday, March 27<sup>th</sup> Accommodations Tax Committee meeting would be his last meeting.

There being no further business the meeting was adjourned.

*A request by the City to amend **Section 6.10 Design Overlay District** to exempt Planned Development Districts (PDD) and Development Agreement Districts (DAD) from regulations in **Section 6.10-2 Permitted Uses** and **Section 6.10-3 Development Standards**.*

**a. Opening Statement**

Carroll Williamson began by explaining to the Commission that certain approved Planned Development Districts (PDD) and Design Agreement Districts (DAD) had also turned out to be located in the Design Overlay District (DOD). Mr. Williamson stated that DOD regulations could cause a conflict when a PDD or a DAD was present. Mr. Williamson gave an example of an approved PDD located in the Knox Abbott Drive DOD. Mr. Williamson stated that this particular plan was approved to have a drinking establishments whereas the DOD did not permit drinking places. Mr. Williamson explained that properties in the 12<sup>th</sup> Street DOD were largely undeveloped and PDDs or DADs may come about in this area. Mr. Williamson stated that conflicts could arise with the DOD regulations. Mr. Williamson explained that a PDD or a DAD specifically lays out what will be allowed so they should be released from DOD standards. Mr. Williamson stated one way to make this happen would be to add an exemption allowing a PDD or a DAD to override DOD regulations if a conflict occurs. Mr. Williamson confirmed that the City Attorney approved the amendment to the section.

**b. Public Testimony**

No one was present to speak for or against the text amendment.

**c. Adjourn Hearing**

With no further discussion, the public hearing was adjourned.
